Forum examines role of innovation in U.S. ag global competitiveness

OAK BROOK, IL Sept. 13, 2017: To meet the growing global demand for food, feed, fuel and fiber, the food and agriculture sectors are seeking new tools from agriculture research and innovation systems. The role of research and innovation in U.S. agriculture, as well as impact on global competitiveness, will be the subject of the Farm Foundation® Forum on Tuesday, Sept. 19, 2017.



The Forum begins at 9 a.m. EDT at the National Press Club, 529 14th Street NW, Washington, D.C.

A panel of international experts will be on hand to offer perspectives on the issue:

- Ken Ash, Director of the Trade and Agriculture Directorate of the Organisation for Co-operation and Development (OECD), will discuss findings and recommendations from an OECD study focused on the United States.
- Catherine Moreddu, Senior Economist at OECD, will highlight lessons drawn from a series of OECD studies completed in other developed nations.
- Margaret Zeigler, Executive Director of the Global Harvest Initiative, will offer perspectives from the private sector.

In addition to the panel, two responders have been asked to provide additional perspectives. They are Parag Chitnis, Deputy Director of USDA's National Institute for Food and Agriculture, and Alan Leshner, CEO Emeritus of the American Association for the Advancement of Science.

Farm Foundation President Constance Cullman will moderate the discussion. After comments by the panelists, the floor will be opened for questions and discussion.

The Forum will be 9 a.m. to 11 a.m. EDT in the Holeman Lounge of the National Press Club. A free, live audiocast will also be available.

There is no charge to participate in the Sept. 19 Forum, but registration is requested.

Researchers, academics and government leaders from the United States and the European Union will examine the role of public policies to support research and innovation, and how to improve the capacity of those policies to deliver demand-driven results.
