Implementation of FSMA: The International Perspective





Current Problems in Global Supply Chain for Enforcement of FSMA

- o Regulatory gaps for mitigating risk, protecting consumer health, and raising consumer confidence
- Inability to handle emergency contamination issues consistently and reliably
- Absence of uniform treatment of domestic and international product
- Frequently less reliable technologies for tracing and certification from point of origin in foreign supplier markets
- Concerns regarding independent, verifiable certification on-site (i.e., "third party audits") and in shipment documentation
- Potential for fraud/gaming the system
- Absence of harmonized standards with international acceptance
- Need for private-public platforms as hosts for information sharing and collaboration
- Lack of equivalency in regulatory systems worldwide


Key FSMA International Provisions

- Sanitary transportation of human and animal food
- Focused mitigation strategies to protect food against intentional adulteration
- Accreditation of third-party auditors
- Foreign supplier verification programs
- Preventive controls for food for animals
- 7 The produce safety rule
- Preventive controls for human food

Status Report of Implementation:

- FDA faces court imposed deadline of June, 2015, to publish regulations, creating uncertainties for producers and manufacturers
- FDA budgetary constraints undermining long-term effectiveness of FSMA
- Continuing and potentially growing discord in grower/ manufacturer/ and international supplier communities

International Footprint



Trade and National Security Interests

- Pathogen viruses and fraud are disruptive to international trade
- Security concerns relating to undetected viruses
- Potential for international misunderstanding and weakening the fabric of international organizations and standards
 - o HACCP
 - Codex Alimentarius

The Role of a Public-Private Platform

- Information exchange
- Joint venture investment in new food safety technologies
 - SPS (Phytosanitary) operating systems
 - o Tracing
 - Certification
- Collaboration B2B and with government regulators to insure uniform compliance with international standards and reduce incentives for fraud
