ABOUT FARM FOUNDATION

Farm Foundation is an agricultural policy institute dedicated to cultivating dynamic non-partisan collaboration to meet society's needs for food, fiber, feed and energy. Farm Foundation is a non-profit organization working to illuminate the issues and elevate the policy discussions surrounding agriculture and rural America. It facilitates engagement and creates opportunities for input from multiple perspectives. The Foundation helps ensure that the issues and policies affecting food and agriculture are objectively analyzed and constructively discussed.

Since 1933 the Foundation has connected leaders in farming, business, academia, issue organizations and government through proactive, rigorous debate and objective issue analysis. The Farm Foundation does not advocate. The 86-year-old reputation for objectivity allows it to bring together diverse stakeholders. Through conferences, workshops and Farm Foundation® Forums, Farm Foundation invites stakeholders to discuss evolving issues shaping rural communities and the food and agriculture sector. The Farm Foundation is also focused on offering opportunities for professional growth for emerging professional leaders in the food and agricultural industry through their Cultivator and Congressional Fellowship Programs. Farm Foundation has an annual operating budget of \$2.8 million, just under half of which is funded by the Legge Lowden Farm Foundation Trust. Farm Foundation is a 501(c)(3) governed by a 29-member Board of Directors. Farm Foundation's offices are in Oak Brook, Illinois, located 15 miles west of downtown Chicago.

The food and agriculture sector face changes generated by structural shifts in global and financial markets, business consolidation, emerging technologies, environmental impacts, government policies, consumer preferences, labor availability and infrastructure limitations. Farm Foundation's goal is to catalyze robust debate, informed policy decisions and new ideas for addressing complex issues. In a tradition that began more than eight decades ago, Farm Foundation helps public and private leaders navigate the challenges and opportunities of such changes.

OPPORTUNITY

Reporting to the Chair of both the Board of Directors of Farm Foundation and the Board of Trustees of The Legge Lowden Farm Foundation Trust, the President has overall strategic and operational responsibility for the staff, programs and execution of its mission. S/he will need to develop a deep knowledge of core programs, operations and business plans along with having extensive fundraising capabilities and experience.

KEY RESPONSIBILITIES

Be a nationally recognized external presence and spokesperson, representing Farm Foundation at events, building new partnerships, establishing and nurturing fundraising relationships and communicating programmatic accomplishments, requiring travel as needed.



- Oversee the development of an annual business plan and related budget and regularly report to the Board of Directors and Trustees on programmatic accomplishments and financial performance, including accurate monthly financial reporting in accordance with GAAP.
- Ensure programmatic excellence and rigorous evaluation of quality, including attention to the Foundation's commitment to objectivity and non-advocacy.
- Lead and coach the Foundation staff in carrying out programs. Maintain an effective performance evaluation system to support employee development and performance.
- Work closely with the Board of Directors and the Trustees to provide strategic direction for the organization. Includes the identification of future programming opportunities and funding sources.
- Work with the Board of Directors and the Trustees to assure that the governance, organizational structures and business operations serve the long-term mission of the Foundation.
- Serves as a non-voting member of the Board of Directors and all Board committees.

- Thorough commitment to Farm Foundation's mission.
- Master's degree or equivalent in a field relevant to agriculture public policy and/or food and agriculture. A PhD or other terminal degree preferred.
- Minimum of 10 years of experience in progressively responsible senior management positions in the not-for-profit sector, the private sector, government, or academia. Experience in not-for-profit management desirable.
