Committee for the Implementation of Textile Agreements (CITA)












- Interagency committee chaired by the Department of Commerce – USTR, State, Treasury, Labor
 - Implement FTA Provisions
 - Commercial availability provisions
 - Administer textile and apparel safeguard actions (China & FTAs)
 - Administer textile and apparel quotas

China Textile Agreement








- Bilateral textile agreement with China reached in November 2005.
- Limits imports from China in 34 individual product categories. Expires December 31, 2008.


Textile and Apparel Imports to U.S.






U.S. Free Trade Agreement Partners in the Global Economy

Common FTA Provisions

- Based on TPA requirement of reciprocity
- Separate textile negotiating group
- Yarn-forward rule of origin, with limited negotiated exceptions
- Safeguard mechanism
- Customs cooperation /anticircumvention



Leveling the Playing Field: The WTO Doha Development



- Launched in Doha, Qatar in 2001.
- Fundamental U.S. objective for textiles, as established by the Trade Promotion Authority, is to obtain reciprocal market access.
- U.S. has stated that textile issues merit special consideration in the Doha Round
- U.S. & EU joint proposal to reduce non-tariff barriers to trade related to labeling of textiles, apparel, footwear and travel goods.
- No consensus among WTO Members about treatment of textiles and apparel.
- Breakthrough in the agriculture negotiations is needed before major progress can occur in other areas.

Vietnam – Import Monitoring Program



- Monitor and review imports of textiles and apparel from Vietnam through end of current Administration.
- Semi-annual review 6 months worth of data.
- Self-initiate dumping case if facts warrant.
- First review completed October 2007; insufficient evidence to warrant self-initiating an antidumping investigation.
- Second review to be completed April 2008.
